Giani, Executive Director of the Utah Department of Commerce, announced today that effective July 30, 2018 Jason Sterzer has been appointed as the new Director of the Division of Corporations and Commercial Code. Sterzer was selected to succeed outgoing Director Kathy Berg who is retiring after 28 years of prominent public service with the State of Utah.

Berg began her storied career in state government with her first post in customer service at the Division of Corporations where her courteous attitude was recognized in a letter from U.S. Senator Orrin Hatch (R-UT).
